Second Chance Promotion Drawing Rules

OVERVIEW:

Beginning any time on March 27, 2017 until 11:59:59 PM on August 21, 2017, players can participate in the Maryland State Lottery and Gaming Control Agency ("Lottery" or "Maryland Lottery") Betty Boop Second Chance Promotion ("Promotion") for a chance to win one (1) of four (4) one-week vacations in Ocean City, Maryland ("Trip Prizes", singular "Trip Prize"). Each Trip Prize also includes a \$1,000 Visa Gift Card. Four (4) drawings will be held. See below for drawing entry deadlines, drawing dates, claiming dates and Trip Prize dates.

To participate, enter at **mdlottery.com/bettyboop** one non-winning Maryland Lottery® Betty Boop™ scratch-off ticket (Game #322) and/or any other ticket specified by the Lottery (collectively, "Ticket") for entry into the Promotion. One (1) winner will be selected in each drawing for a total of four (4) winners in the Promotion. One Trip Prize will be awarded in each drawing. Pollard Banknote Limited ("Pollard") will be providing complete fulfillment of all Trip Prizes. See Trip Prize Description below for a more complete description of the Trip Prize.

For each drawing: Entries must be entered for a specific drawing by 11:59:59 PM Eastern Time on the announced Drawing Entry Deadline date (see above) to be eligible for that drawing. (In these Betty Boop™ Second Chance Promotion Drawing Rules ("Rules"), all times are Eastern Time.) Entries are not cumulative. Each drawing must be entered individually for an entry to be included in that drawing. Only one drawing period is open at a time. A drawing may include any random selection event. These are bonus drawings.

Internet access and a valid email address are required to enter this Promotion and its drawings. Mailed entries will not be accepted. You may enter as often as you like; however, you may only win once. One Ticket equals one entry into the Promotion. Only non-winning Tickets are valid entries. You do not need to keep your original ticket in order to claim your prize if you win. (Players and winners are sometimes referred to as "you" and "your".) A Ticket may only be used to enter one time.

Trip Prizes Descriptions:

<u>Trip Prize</u> - One week (8 days/7 nights) at a condo in The Belmont Towers (occupancy limit 8) in Ocean City, Maryland; \$1,000 Visa Gift Card. Notwithstanding the provisions in the Lodging Agreement requiring "family groups only", "family groups" are defined to include groups of up to eight (8) people who are not necessarily family members, if that group includes the person checking in, age twenty-five (25) or older, whose credit card is on file with Vantage for the Property. If winner or the person checking in has not checked in within 24 hours of 3:00 p.m. on the check-in date, and other arrangements have not been made, the reservation may be cancelled and all rental fees will be forfeited. Linens are included. Winner must provide their own soaps, paper products and beach towels, etc. Sleeping arrangements include one (1) king, one (1) queen, two (2) singles and one (1) queen sleep sofa. Winner agrees that winner and all guests will comply with the Lodging Agreement. Two parking spaces provided. Vehicle restrictions apply (parking clearance 6' 9"). Winner is responsible for all incidentals and amenities and damages. Estimated Trip Prize value: July 1-8, 2017 Trip Prize: \$6,207.48 (before taxes are paid*); July 29-August 5, 2017 Trip Prize: \$6,428.48 (before taxes are paid*); August 26-September 2, 2017 Trip Prize \$4,505.78; September 23-September 30 Trip Prize \$3,163.20

Trip Prize winners acknowledge and agree:

- when claiming your prize, the winner is required to sign the terms and conditions in the Lodging Agreement ("Lodging Agreement" or "Lease") and waiver and release for your Trip Prize (By signing the waiver and release of liability, the winner accepts responsibility on behalf of their guest(s).);
- 2) winner's failure to sign the Lodging Agreement and waiver at the time of claiming the Trip Prize may result in cancellation and cancellation fees will apply (but see also 3, 4, and 5 immediately below);
- 3) the winner must sign and submit the Lease unless the winner is not at least 25 years of age and/or and does not have a valid credit card;
- 4) if the winner is not at least 25 years of age and/or does not have a valid credit card, the winner must designate someone who is at least 25 years of age with a valid credit card to sign and submit the Lease (the designated person must sign at the time of claiming);
- the person who signs the Lease must have and provide a valid credit card at the time of claiming and will be responsible for incidentals, amenities, damages, and for compliance with property rules, regulations and provisions as set forth in the Lease;
- 6) the person who signs the Lease must attend and be present at/occupy the property provided as the Trip Prize ("Property"), for the entire duration of the Trip Prize;
- 7) to refer to Lodging Agreement for more specific lodging information and requirements.
- 8) Trip Prize does not include revision or cancellation fees which may be charged by the hotel or other suppliers unless incurred by an act or omission of Pollard or any of Pollard's subcontractors, or any other items not expressly specified in the Official Rules, Rules or waiver and release for this Promotion. Trip Prize winners are responsible for payment of these amounts
- 9) No pets are allowed.
- 10) No smoking of any kind on the Property, including e-cigarettes and vaporizers.
- 11) Winners must provide their own transportation.
- 12) If a Trip Prize winner(or, if winner designates a person to sign the Lease, that designated signer) is unable to check in on the first day of the Trip Prize or must check out before the end of that week, any portion(s) of the Trip Prize missed shall be forfeited. The person who signs the Lease must be the person checking in, and is required to occupy the "Property" and to supervise the winner's guest(s) for the entire duration of the Trip Prize. For any period of time that the person who signs the Lease does not occupy the Property, no one may occupy the Property. Trip Prize dates are firm.

As a further bonus prize, the Lottery will pay the required estimated State and Federal tax withholdings on the July 1-July 8, 2017 and the July 29-August 5, 2017 Trip Prizes. The payment of tax withholdings could result in additional Federal and State tax liability being due from the winner. Winner is responsible for all other taxes, including income taxes in excess of withholdings paid by the Lottery.

Each winner of the August 26-September 2, 2017 and the September 23-September 30, 2017 Trip Prizes is responsible for all taxes, including income taxes. Winners will receive a W-2G from the Lottery.

CLAIMING:

You will be advised, at the time of notification, of claiming procedures and reminded of claiming deadlines. Winners and alternates for each drawing must claim your prize in **person by 4:30 on the dates listed in the chart above** at the Maryland Lottery Baltimore Customer Resources Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD 21230.

If you win a Trip Prize (each is valued over \$600), and you owe State Obligations, then you must pay those outstanding State Obligations within two (2) business days in order to receive the Trip Prize. If any of those outstanding State Obligations are not paid off within two (2) business days of claiming the Trip Prize, then, at the option of the Lottery, you will be disqualified and an alternate winner may be selected. You may not assert any right or remedy on account of any substitution, disqualification, lack of refund, rescheduling, or other action by the Lottery.

If the Property becomes unavailable to the Lottery, then Pollard or the Lottery may substitute for any Property with a package of equal or higher value. The winner and any guests agree to accept the substitution.

Trip Prizes may not be sold. Trip Prizes may not be used by anyone other than the prize winner without the Lottery Director's written approval.

You do not have the option to request or receive a substitute or equivalent prize, including cash, for any prize.

OTHER OFFICIAL RULES:

If any discrepancy should exist between these Rules and any other material describing this Promotion or anything related thereto, these Rules shall prevail.

All aspects of this Promotion are governed by these Rules.
