OVERVIEW:

Beginning August 31, 2012, every Maryland State Lottery Agency ("Lottery" or "Maryland Lottery") Mega Millions® ticket with Megaplier® and Powerball® ticket with Power Play® ("Ticket"; plural "Tickets") issued in Prince Georges and Montgomery Counties throughout the regular 2012 football season will feature a Washington Redskins™ ("Redskins") logo at the top of the Ticket. Players purchasing one of these Tickets will have a chance to win Redskins™ Family "Game Day" Four (4) Packages, or 2013 Redskins Season tickets, simply by entering, at mdlottery.com/redskins, the 16-digit ticket serial number located both at the top left and also at the bottom right of your **non-winning** Ticket. A total of \$47,345 worth of cash and Redskins prizes will be awarded throughout the Redskins Mega Power Promotion ("Promotion")! Only non-winning Tickets with a Redskins logo at the top will be eligible for entry in this Promotion.

Prizes:

Redskins Family "Game Day" Four (4) Package Prize: includes four (4) Lower Level tickets to a 2012 regular season Redskins home game, a one-game premium parking pass, four (4) replica jerseys, and \$500.

Redskins Season Tickets Prize: includes two (2) Upper Level tickets for the 2013 home football season, a premium parking pass, two (2) replica jerseys, and \$5,000.

The Lottery will conduct a series of sixteen (16) weekly drawings ("Drawings"; singular, "Drawing") throughout the 2012 football season beginning Thursday, September 6, 2012. The Drawings will take place every Thursday throughout the Promotion with the exception of Thanksgiving week. A total of 19 winners will be selected.

Entries for the Redskins Mega Power Promotion must be entered by 9 AM Eastern Time on the Drawing entry deadline date to be eligible for that Drawing. (In these Rules, all times are Eastern Time.) Entries for this Promotion will be accepted at any time beginning 12 AM August 31, 2012 through 9 AM of the final Drawing entry deadline date for the last Drawing, December 27, 2012 ("Promotion period").

To enter, you must be 18 years of age or older.

Actual prizes may vary, depending upon availability. This is a bonus game and portions of these prizes are bonus prizes.

HOW TO ENTER:

To enter this Promotion, visit the Lottery website at mdlottery.com/redskins. You will be directed to the registration page and will be required to enter the 16-digit serial number (located at both the top left and the bottom right on the front of your non-winning Ticket), your name, address (street, city, zip code), (and optionally, phone number and/or email address) in the fields provided. (Providing your phone number and/or email address will make it easier and quicker to contact you in the event you win.) Once your entry has been correctly submitted, you will receive an on-screen message acknowledging that your entry has been accepted.

YOU MUST KEEP YOUR ORIGINAL TICKET, AND YOU MUST PRESENT IT TO THE MARYLAND LOTTERY TO VALIDATE YOUR ENTRY IF YOU WIN.

Entries must be entered by 9 AM on the respective Drawing entry deadline date to be eligible for a given Drawing. A "drawing" may include any random selection event. Entries are included in only one Drawing. **You must enter each Drawing separately to be included in that Drawing.** The Drawing entry deadline dates, their respective prizes, prize values, and claiming deadlines are as follows. **Winners and alternates must claim your prize by 4:30 PM of the respective claiming deadlines.**

Entries received after the final Drawing deadline of 9 AM, Thursday, December 27, 2012, will be ineligible.

Entries submitted should list one name only, or the Lottery will choose which name is the winner. No ticket other than non-winning Maryland Lottery Mega Millions with Megaplier or Maryland Lottery Powerball with Power Play tickets may be used to enter this Promotion or these Drawings. Tickets originally winning on the Ticket itself are not valid entries and will not be considered.

You may enter as often as you like. This Promotion is governed by these Official Rules and Conditions of Eligibility ("Rules"). By participating in this Promotion, you agree to be bound by these Official Rules and Conditions of Eligibility. (Players and winners are sometimes referred to as "you" or "your").

The Lottery reserves the right to reschedule any times and dates regarding any of the Drawings in this Promotion, if necessary, without advance notice.

CLAIMING:

All winners of the Promotion Drawings will be notified via telephone and/or e-mail and/or certified mail to confirm eligibility. The Lottery, in its sole discretion, may choose to use additional or alternate means or methods to notify the winners. **You will be advised, at the time of notification, of claiming procedures and claiming deadlines.** Claiming deadlines for winners and alternates are included in the chart above. Winners must claim your prize in person by 4:30 PM of the claiming deadline at the Maryland Lottery Baltimore Customer Resource Center, Montgomery Park Business Center, 1800 Washington Boulevard, Suite 330, Baltimore, MD. If a winner has not claimed or been confirmed as eligible, or has not submitted all required documentation by the respective claiming deadline date, or declines the prize or has been disqualified, then an alternate winner may be selected. Alternates must claim by 4:30 PM of the claiming deadline designated for alternates.

All winners must complete a Lottery Claim Form, including Social Security number (SSN), and must provide proof of your SSN and must furnish photo I.D. proof of being at least 18 years of age, and must provide the physical non-winning Ticket. You must present your original, physical Ticket with the correct matching 16-digit serial number and with the registered name related to your Internet entry in order to claim your prize. If the name on the Ticket does not match the name on the Internet, then the entry is invalid. If more than one name is provided on any winning entry, the prize will be deemed won by the name registered on the Internet. Allow a minimum of 15 business days after the Lottery receives a claim for delivery of any prize other than the prizes to events with a specific date.

As a further bonus prize, the Lottery will pay the required estimated State and Federal tax withholdings on the Redskins 2013 Season Tickets prizes. (However, see the paragraph below). Further amounts may be owed. The payment of tax withholdings could result in additional Federal and State tax liability being due from the winner. Winner is responsible for all other taxes, including income taxes in excess of withholdings paid by the Lottery.

If you win an experiential prize ("Prize") with a total value greater than \$600 and you owe State Debts, which include but are not limited to child support and/or certain other debts to a State agency or other governmental entity, then you must pay those outstanding State Debts in order for the

Prize to be awarded to you and any cash portion of the Prize will be applied to your State Debts; if any of those outstanding State Debts are not paid off within five (5) business days of claiming the Prize, then you will be disqualified and an alternate winner will be selected. Further amounts may be owed. All amounts paid to you or on your behalf will be included in your reportable income. You will be taxed on those amounts. All winners are responsible for all taxes, including income taxes. You will receive a W-2G form for any prize won with a value greater than \$600.

Prizes may not be sold.

In the event of winner's death or inability to partake of a prize, the Lottery will make a determination about the awarding of the prize.

You do not have the option to request or receive a substitute or equivalent prize, including cash, for any prize. In the event that a prize is to an event with a specific date and that event is cancelled or rescheduled, the Lottery and the Redskins shall not be subject to any liability, and the Lottery, a) may substitute a prize of equivalent value, however that prize might not be for the same date, or b) may reschedule that prize.

OTHER OFFICIAL GAME RULES:

By entering this Promotion, you agree to participate in any related Lottery event, including any Lottery event that may be public, taped, or televised, or to send a proxy who will participate. The Lottery reserves the right to approve or reject any proxy designated by a winner. All winners in any public, taped, or televised Lottery event agree to behave in a reasonable, respectful and cooperative manner and to not be under the influence of drugs or alcohol. Winners also agree to wear to any public, taped, or televised Lottery event clothing that contains no logos or writing, and the Lottery reserves the right to determine what clothing is acceptable for appearing in the public, taped, or televised Lottery event. The Lottery also reserves the right to require the winners and any proxies to wear clothing provided by the Lottery. The Lottery reserves the right to appoint a proxy or stand-in if the winner's or proxy's clothing or behavior is not acceptable, or as otherwise determined by the Lottery, in the Lottery's reasonable sole discretion.

By submitting an entry for this Promotion, or participating in this Promotion or any of its prizes or related events in any way, all Lottery players, winners, participants, you, and guests acknowledge, understand, consent and agree to the following:

- a) to release and hold harmless the Maryland State Lottery Agency, the Maryland State Lottery Commission, the State of Maryland and their members, agents, employees, representatives, successors and assigns (individually and collectively, "MSLA") from any liability arising out of participation in this Promotion, any of its Drawings, any related event or occurrence, and/or out of the awarding, receipt, possession, use, misuse, and/or acceptance of a prize, from any breach of any obligation(s) by any third party(s), and/or from any injury, death, or damage resulting from participation in this Promotion, its individual Drawings, and/or its prizes and/or use of its prizes;

- f) that MSLA is not responsible for any negligence of any person, or for any claim, liability, injury, death, property loss, or other damage of or to Lottery players, winners, guests, and/or other participants, and/or their family members, and/or other persons, arising directly or indirectly from or in connection with the participation in or the use or misuse of prizes awarded, or with participation in this Promotion or in any event or occurrence related to this Promotion, including, but not limited to claims for damage to property, for personal injury or death, or claims based on defamation, rights of privacy, rights of publicity, or delivery of cash or merchandise, or other prize;
- g) that MSLA has not made, and is not responsible or liable for, any warranty, representation or guarantee, express or implied in fact or in law, relative to any prize, including but not limited to its quality, mechanical condition, or fitness for a particular purpose;
